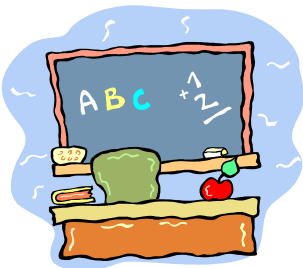

The 2006-07 school year will be one of transition for Illinois NCA. As we continue to provide service and assistance to all member schools, we will also begin to gear up in preparation for the new standards and accreditation process that has resulted from our unification with the Southern Association CASI and the National Study of School Evaluation. AdvancED is the parent organization of NCA CASI, SACS CASI and NSSE and will serve 21,000 public and private schools and districts in 30 states and 65 countries, touching 15 million students. Through AdvancED, NCA CASI and SACS CASI will transition from setting standards for their respective regions to establishing unified quality standards for education in a global society. The transformation is from regional accreditation to a global system of accreditation, continuous improvement, and research.

The aspects schools value about NCA are not changing. All schools will continue to receive the NCA accreditation seal that is recognized around the world. Schools will continue to work with their state offices and local professional development will continue. I am very excited about the unification—schools will not be asked to “undo” what they are doing but will respond to all aspects of continuous improvement, not just the planning and documenting.

## District Accreditation — Is it right for you?

**District Accreditation** continues to gather momentum across the country. It is a systems approach to school improvement that helps district leaders focus their efforts, energies and resources to raise student achievement. Accreditation at the District level is specifically designed for administrators who are dedicated to district-wide success.

### It's Question Time!

#### ⇒ *How Does District Accreditation Work?*

High standards, continuous improvement and external review—the characteristics central to NCA CASI school—level accreditation—are also the characteristics of District Accreditation. District Accreditation assesses the ability of the central office to support, drive, and monitor a continuous improvement process for all of its schools.

#### ⇒ *How is District Accreditation Granted?*

A district may earn term accreditation for all of its schools by demonstrating that it has met the criteria for District Accreditation.

#### ⇒ *How Much Does District Accreditation Cost?*

District Accreditation can help district leaders streamline multiple improvement initiatives and focus resources on meeting the needs of all of their schools. The district pays the accreditation dues for each school as well as the costs of the external visits. Because district administrators manage the external school review process internally, the process can result in considerable cost savings.

#### ⇒ *What Commitments Are REQUIRED From the District?*

All of the schools in the district must seek or hold NCA CASI accreditation. The district must designate one internal staff member to co-ordinate all improvement efforts.

#### ⇒ *What Are the Benefits?*

- Earn NCA accreditation, a nationally-recognized mark of quality, for the system and all schools within the system.
- Focus the entire district on the primary goals of improving student achievement and creating lifelong learners.
- Meet and exceed local, state, and federal requirements through a unified and streamlined process.
- Reduce duplication of effort and costs across the system.
- Improve communications, articulation and the sharing of best practices.
- Enhance local control and district-wide management of the continuous improvement process
- Receive external validation and support of your improvement efforts
- Increase the district's capacity to assess its own needs and respond effectively.



I am personally excited about the potential and possibilities associated with District Accreditation. If you are interested in becoming one of the first Districts in Illinois to pursue accreditation and would like to discuss this further, please contact the Illinois NCA office.
